BACK TO NORMAL - AND LOOKING FORWARD

It is a pleasure to report that after two years of disrupted operations due to Covid accommodations and restrictions, the 2022-2023 school year has had a tremendous feeling of normalcy! Morning Assembly has been back in the gym on a daily basis. We created a piano lab for a new music program, designed to develop music reading skills and teach piano to all students over the course of their time at the school. We resumed our relationship with UMass Dartmouth for art classes after a 3-year hiatus. We have resumed weekly community service programming with several local organizations. We held Community Thanksqiving and several family and community events we haven't held in years. Sports teams resumed fuller schedules, with the basketball team coming in 2nd place in the Nativity Boston Tournament and winning the MABACH Tournament (Math-Basketball-Chess), held for the first time since 2019. In a word, this feels GREAT – the positive vibes are back!

Maybe most impressive are the results of our first round of standardized testing this past fall. While national statistics show that most commonly there has been a significant drop in student testing results pre- and post-Covid, our results were nearly constant. Whether this was the result of the exceptional work of our faculty, the way Nativity structured its learning program during the pandemic and the individual extra help that was provided, the conscientiousness of our students, or the initiation of a Chromebook program for every student - in fact, it was all of the above - it is something we take great pride in and are working to build on this year.

Additionally, as you know from reading the Winter Newsletter, the Board determined that coming out of Covid and having passed our 20th anniversary of serving the young men of New Bedford, it was an appropriate time to assess "where we are," to take a critical look at all aspects of our operations, and to intentionally plan for the next phase of Nativity's growth. To assist us in this effort, we have partnered with a consulting group out of Boston, TDC, and are spending the year engaged in a comprehensive strategic planning effort that will help us to identify our next set of goals and the steps necessary to reach them. This is an exciting exercise and it is an exciting time to be at Nativity. None of what has just been mentioned could have been accomplished without the continued generosity of our friends and supporters throughout the pandemic. Fulfilling our mission for the young men we serve is truly a community event, and we could not have met the challenges of the last few years as effectively as we did without the tremendous loyalty of the extended Nativity family. That said, we hope for your continued partnership as we work to implement the results of our strategic planning effort and take Nativity to the "next level." Our school is strong. Our opportunities are unlimited. Our appreciation for your support and generosity is deep and sincere. We cannot thank you enough, and are pleased to present this year's Annual Report for your review.


